- 18% of Sandusky area students did not graduate last year.
- About 42% of Erie County school children are not proficient in reading by the 4th grade.

A HEALTHY LIFE

BECAUSE

- 1,100 allegations of child abuse, neglect, or threat of harm in Erie County in 2015.
- In 2016, 14% of Erie County youth were classified as obese. 12% of Erie County youth were classified as overweight by Body Mass Index (BMI) calculations

BECAUSE

- 22.1% of the population in Erie County lives in poverty
- Over 3400 Erie County individuals and families were given assistance as a result of a disaster/ emergency situation.
